Dear Senator McGuire:

On behalf of the Board of Supervisors, I respectfully write in opposition to SB 649 (Hueso). This measure removes local authority over public property and eliminates public input and local discretion of the aesthetic and environmental impacts of small cells.

SB 649 would eliminate discretionary review for the installation of small cells in significant portions of communities and everywhere within the public-right-of-way. This would limit Sacramento County's discretion and the ability to consider public input and aesthetics impacts of small cells installed within the public right-of-way in all zones (including residential neighborhoods) or anywhere inside or outside of the public right-of-way in mixed use residential/commercial zones. Counties would only be able to approve small cells located in these areas through an "administrative permit."

SB 649 also contains ambiguities that negatively impact Sacramento County. SB 649 does not clarify what constitutes an administrative permit for the purposes of this bill. It is unclear if a building permit or an encroachment permit qualifies as an administrative permit. The conditions of what can be applied by the local government under this administrative review are also vague. It is also unclear whether the small cell could extend the height of the vertical infrastructure, which currently requires an entitlement review. Sacramento County is concerned about losing discretion over aesthetic considerations, especially since SB 649 would require the installation of small cells on streetlights and other infrastructure that has not previously been used for communications or electrical transmission purposes. Sacramento County should be able to maintain its traditional level of control over the time, place, and manner of encroachments to the public right-of-way to guarantee public safety.
